The text of the International Standard from Technical Committee ISO/TC 68 "Banking and related financial services" of the International Organization for Standardization (ISO) has been taken over as an European Standard by Technical Committee CEN/TC 224 "Machine-readable cards, related device interfaces and operations", the secretariat of which is held by AFNOR.
