Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Dental Handpieces – Part 1: High-Speed Air-Turbine Handpieces (ISO 7785-1:1992)) Declaration, 1994.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Dental Handpieces – Part 1: High-Speed Air-Turbine Handpieces (ISO 7785-1:1992). The Schedule comprises the text of EN 27785-1 : 1994.

(2) The said standard specification may be cited as Irish Standard/EN 27785-1:1994 or as I.S./EN 27785-1:1994.

Foreword

This European Standard has been taken over by Technical Committee CEN/TC 55 "Dentistry" from the work of ISO/TC 106 "Dentistry" of the International Standardization Organization (ISO).

ISO 7785 consists of the following parts, under the general title "Dental handpieces":

- Part 1: High-speed air-turbine handpieces
- Part 2: Straight and geared angle handpieces

The text was submitted to the Unique Acceptance Procedure (UAP) and approved as a European Standard.

This European Standard shall be given the status of a national standard, either by publication of an identical text or by endorsement, at the latest by November 1994, and conflicting national standards shall be withdrawn at the latest by November 1994.

In accordance with the CEN/CENELEC Internal Regulations, the following countries are bound to implement this European Standard: Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and United Kingdom.
