Schedule comprises the text of EN 61248-1:1997.
- (2) The said standard specification may be cited as Irish Standard EN 61248-1:1998 or as I.S. EN 61248-1:1998.
- 3. (1) The Standard Specification (Custom-Built Transformers and Inductor Cores (Generic Specification)) Declaration, 1994 is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 126000:1994 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 61248-1:1998.
