DECLARATION, 1986

IRISH STANDARD 205: PART 3-1: 1986

EOLAS - The Irish Science and Technology Agency in exercise of the power conferred by section 20(5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Science and Technology Act, 1987 (No. 30 of 1987), and with the consent of the Minister for Industry and Commerce, hereby declares as follows:

- 1. This instrument may be cited as the Standard Specification (Safety of Household and Similar Electrical Appliances, Part 3-1, Particular Requirements for Pedestrian Controlled Mains-Operated Electric Lawn-Mowers and Similar Gardening Appliances) Declaration, 1986 (Amendment) No. 1: 1989.
- 2. Irish Standard 205: Part 3-1: 1986 set out in the Schedule to the Standard Specification (Safety of Household and Similar Electrical Appliances, Part 3-1, Particular Requirements for Pedestrian Controlled Mains-Operated Electric Lawn-Mowers and Similar Gardening Appliances) Declaration, 1986 is hereby amended as indicated in the Schedule hereto.

Schedule

Page 4, Sub-clause 7.1

Delete paragraph beginning "For appliances with tools which" and replace with the following:

"For appliances with tools not stopping within 7s after the motor has been switched off visual indication of rotation of the moving parts shall be provided.

Moreover a label shall be provided with the following warning:"

Page 4, Sub-clause 7.12

Delete third indent beginning "For appliances not supplied with" and replace with the following:

" - The portable socket-outlet on a cord extension set must be splash proof."

Page 6, Sub-clause 8.1

Insert heading as follows: "Addition:".

Page 15, Clause 21

At top of page delete heading "Addition:" and replace with "Modification:".

Page 15, Sub-clause 21.101.1

In the second line delete "1000 g/m^2 " and replace with "1800 g/m^2 ".

Page 16, Sub-clause 21.102.2

In the second line delete "2369 $(10^{-2})(L^3)$ " and replace with "2.369 $(10^{-2})(L^3)$ ".

In the third paragraph delete "or lh" and replace with "for lh".


Page 16, Sub-clause 22.2

At the bottom of the page delete the sentence beginning with "The appliance other than" and replace with the following:

"Appliances without a stable position of application shall be at least splash-proof".

Page 20, Add a new Sub-clause 22.105 as follows:

"For appliances other than lawn-mowers having a cutting means consisting of a rotating string, that string shall be made of non-metallic material".


