- 1. This instrument may be cited as the Standard Specification (Electromagnetic compatibility Generic immunity standard Part 1: Residential, commercial and light industry) Declaration, 1998.
- 2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Electromagnetic compatibility Generic immunity standard Part 1: Residential, commercial and light industry. Schedule comprises the text of EN 50082-1:1997.
- (2) The said standard specification may be cited as Irish Standard EN 50082-1:1998 or as I.S. EN 50082-1:1998.
- 3. (1) The Standard Specification (Electromagnetic Capability Generic Immunity Standard. Part 1: Residential, Commercial and Light Industry) Declaration, 1992 is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 50082-1:1992 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 50082-1:1998.
