- 1. This instrument may be cited as the Standard Specification (Quality management and quality assurance Vocabulary (ISO 8402 : 1994)) Declaration, 1995.
- 2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Quality management and quality assurance Vocabulary (ISO 8402 : 1994). The Schedule comprises the text of EN ISO 8402 : 1995.
- (2) The said standard specification may be cited as Irish Standard/EN ISO 8402:1995 or as I.S./EN ISO 8402:1995.
- 3. (1) The Standard Specification (Quality Vocabulary (ISO 8402 : 1986)) Declaration, 1991 is hereby revoked.
- (2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/ EN 28402 : 1991, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 8402:1996.
