2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for General methods of test for pigments and extenders - Part 15 : Comparison of resistance to light of coloured pigments of similar types (ISO 787-15 : 1986). The Schedule comprises the text of EN ISO 787-15 : 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO 787-15:1996 or as I.S./EN ISO 787-15:1996.
