Part 3: Sectional specification for power transformers on the basis of the capability approval procedure (IEC 61248-3:1996). The Schedule comprises the text of EN 61248-3:1997.  
(2) The said standard specification may be cited as Irish Standard EN 61248-3:1998 or as I.S. EN 61248-3:1998.
