The text was prepared by CEN/TC 222/WG3 "Other finished articles filled with feather and down e.g. clothing, sleeping bags, cushions", the Secretariat of which is held by France.

This standard includes a Bibliography.

### 1 Scope

This standard specifies the characteristics for textile fabrics (outer shell, filling shell, lining) and filling of clothing (light use purposes) solely filled with feather and/or down .
