Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 ( No. 20 of 1961 ) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification ( Fibre-cement pipes for sewers and drains - Part 1: Pipes, joints and fittings for gravity systems) Declaration, 1997.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Fibre-cement pipes for sewers and drains - Part 1: Pipes, joints and fittings for gravity systems. The Schedule comprises the text of EN 588-1:1996.
