Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Information technology - Coding of moving pictures and associated audio for digital storage media at up to about 1,5 Mbit/s - Part 1 : Systems (ISO/IEC 11172-1 : 1993)) Declaration, 1996.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology - Coding of moving pictures and associated audio for digital storage media at up to about 1,5 Mbit/s - Part 1 : Systems (ISO/IEC 11172-1 : 1993). The Schedule comprises the text of EN ISO/IEC 11172-1 : 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO/IEC 11172-1:1996 or as I.S./EN ISO/IEC 11172-1:1996.
