Forfás in exercise of the power conferred by section 20 (5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Identification cards - Identification of issuers - Part 2 : Application and registration procedures (ISO/IEC 7812-2 : 1993)) Declaration, 1995.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Identification cards - Identification of issuers - Part 2 : Application and registration procedures (ISO/IEC 7812-2 : 1993). The Schedule comprises the text of EN ISO/IEC 7812-2: 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO/IEC 7812-2:1995 or as I.S./EN ISO/IEC 7812-2:1995.

3. (1) The Standard Specification (Identification Cards - Numbering System and Registration Procedure for Issuer Identifiers (ISO 7812, 2nd Edition, 1987)) Declaration, 1991 is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 27812:1991 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO/IEC 7812-2:1995.
