#### Foreword

#### **FOREWORD**

ISO (the International Organization for Standardization) is a worldwide federation of national standards institutes (ISO Member Bodies). International Standard ISO 183 therefore replaces ISO Recommendation R 183-1961 to which it is technically identical.
