EOLAS - The Irish Science and Technology Agency in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Science and Technology Act, 1987 (No. 30 of 1987), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Information Systems Interconnection – Virtual Terminal – Basic Class – VT Font Assignment Type 1) Declaration, 1993.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information Systems Interconnection – Virtual Terminal – Basic Class – VT Font Assignment Type 1. The Schedule comprises the text of ENV 41513 : 1992.

(2) The said standard specification may be cited as Irish Standard/ENV 41513 : 1993 or as I.S./ENV 41513 : 1993.

CEN/CENELEC members are required to announce the existence of this ENV in the same way as for an EN and to make the ENV available promptly at national level in an appropriate form. It is permissible to keep conflicting national standards in force (in parallel to the ENV) until the final decision about the possible conversion of the ENV into an EN is reached.

CEN/CENELEC members are the national standards bodies and national electrotechnical committees, respectively, of Austria, Belgium, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and United Kingdom.
