NSAI in exercise of the power conferred by section 16 (5) of the National Standards Authority of Ireland Act, 1996 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Auxiliaries for lamps - Ballasts for discharge lamps (excluding tubular fluorescent lamps) General and safety requirements (IEC 60922:1997)) Declaration, 1998.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Auxiliaries for lamps - Ballasts for discharge lamps (excluding tubular fluorescent lamps) General and safety requirements (IEC 60922:1997). Schedule comprises the text of EN 60922:1997.

(2) The said standard specification may be cited as Irish Standard EN 60922 :1998 or as I.S. EN 60922:1998.
3. (1) The Standard Specification (Ballasts for Discharge Lamps (Excluding Tubular Fluorescent Lamps) – General and Safety Requirements (IEC 922:1989)) Declaration, 1992 and its Amendments are hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 60922:1992 and its amendments thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN 60922:1998.
