Forfás in exercise of the power conferred by section 20 (5) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Information technology - International Standardized Profile RA - Relaying the Connectionless-mode Network Service - Part 8 : Definition of profile RA51.1111, relaying the Connectionless-mode Network Service between CSMA/CD LAN subnetworks and PSDNs using virtual calls over a PSTN leased line permanent access (ISO/IEC ISP 10613-8 : 1994)) Declaration, 1996.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology - International Standardized Profile RA - Relaying the Connectionless-mode Network Service - Part 8 : Definition of profile RA51.1111, relaying the Connectionless-mode Network Service between CSMA/CD LAN subnetworks and PSDNs using virtual calls over a PSTN leased line permanent access (ISO/IEC ISP 10613-8 : 1994). The Schedule comprises the text of EN ISP 10613-8: 1996.

(2) The said standard specification may be cited as Irish Standard/EN ISP 10613-8 : 1996 or as I.S./EN ISP 10613-8 : 1996.
3. (1) The Standard Specification (Information Systems Interconnection – Relaying the Connectionless-mode Network Service - Part 8 : Profile RA51.1111 (M-IT-02 R/22 Over PSDN Leased Line)) Declaration, 1993 is hereby revoked.

(2) Reference in any other standard specification to the Instruments hereby revoked and to Irish Standard/ENV 41801-8 : 1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISP 10613-8:1996.
