2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Tractors, machinery for agriculture and forestry, powered lawn and garden equipment - Symbols for operator controls and other displays - Part 5 : Symbols for manual portable forestry machinery (ISO 3767-5 : 1992). The Schedule comprises the text of EN ISO 3767-5: 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO 3767-5:1996 or as I.S./EN ISO 3767-5:1996.
