Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 ( No. 20 of 1961 ) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification ( Information technology - Coding of moving pictures and associated audio for digital storage media at up to about 1,5 Mbit/s - Part 2 : Video (ISO/IEC 11172-2 : 1993)) Declaration, 1996.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Information technology - Coding of moving pictures and associated audio for digital storage media at up to about 1,5 Mbit/s - Part 2 : Video (ISO/IEC 11172-2 : 1993). The Schedule comprises the text of EN ISO/IEC 11172-2 : 1995.  
  
(2) The said standard specification may be cited as Irish Standard/EN ISO/IEC 11172-2:1996 or as I.S./EN ISO/IEC 11172-2:1996.
