1 Scope

This standard specifies a method for checking the capability of relays and contactors to withstand mould. It shall be used together with EN 2349-100.

2 Normative references

3 Method

3.1 Mounting

The relay or contactor shall be wired in accordance with the product standard.

3.2 Procedure

The relay or contactor shall be subjected to a mould test in accordance with ISO 7137. The test period shall be 28 days.

4 Requirements

Test in accordance with EN 2349-201. There shall be no sign of attack by mould.
