AGGREGATES FOR CONCRETE

The Institute for Industrial Research and Standards in exercise of the power conferred by section 20 of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and with the consent of the Minister for Industry and Commerce hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Aggregates for Concrete) Declaration, 1974.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Aggregates for Concrete.

(2) The said standard specification may be cited as Irish Standard 5 : 1974 or as I.S. 5 : 1974.

3. (1) The Standard Specification (Coarse and Fine Aggregates from Natural Sources for Concrete) Order, 1949 (S.I. No. 354 of 1949) is hereby revoked.

(2) Reference in any other standard specification to the Order hereby revoked and to Irish Standard 5 : 1949, thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard 5:1974.
