## Introduction

Candles have accompanied mankind for more than 2 000 years serving above all as a light source. Closely connected to the development history of the candle are the efforts made to improve its quality and its safety in use. Discussions in the past and present over possible self-forming, harmful emissions and fires caused by unsafe candles and/or inappropriate use during the burning of candles have led to consumers concern for these issues.

Most fire damage caused by candles can be attributed to improper use by the consumer. The fire risk of the candle due to inappropriate use can be minimized by suitable warnings for the consumer. These warnings should be easily and non-verbally comprehensible.
