FOREWORD

This standard has been formulated by the Utilisation and Appliances Technical Committee TC3 of the Gas Technical Standards Committee to implement the European Standard EN 26.

Technical Committee TC3 has decided that in addition to the requirements of the European Standard EN 26 shown in Section 1 plus amendments, gas fired water heaters sold in Ireland must also conform to the requirements shown in Section 2.

This standard specification is divided into two sections. Section 1 contains EN 26 together with amendments effective from 31st May 1979, and accepted by the European Committee for Standardization (CEN). Section 2 contains details of the national requirements and conditions which apply to Ireland and which are not included in Tables 12, 13, 14 and 15 in Clause 6 of EN 26.
