Forfás in exercise of the power conferred by section 20 (5) of the Industrial Research and Standards Act, 1961 ( No. 20 of 1961 ) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Paints and varnishes - Print-free test (ISO 3678 : 1976)) Declaration, 1995.

2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Paints and varnishes - Print-free test (ISO 3678 : 1976). The Schedule comprises the text of EN ISO 1517: 1995.

(2) The said standard specification may be cited as Irish Standard/EN ISO 3678:1995 or as I.S./EN ISO 3678:1995.

3. (1) The Standard Specification (Paints and varnishes - Print-free test (ISO 3678 : 1976)) Declaration, 1988 is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/ISO 3678:1988 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 3678:1995.
