Forfás in exercise of the power conferred by section 20 (3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961) and the Industrial Development Act, 1993 (No. 19 of 1993), and with the consent of the Minister for Enterprise and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Identification Cards – Contactless Integrated Circuit(s) Cards – Part 1: Physical Characteristics (ISO/IEC 10536-1:1992)) Declaration, 1995.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Non-Alloy Steel Rod for Drawing and/or Cold Rolling – Part 4: Specific Requirements for Rod for Special Applications. The Schedule comprises the text of EN ISO/IEC 10536-1 : 1994.

(2) The said standard specification may be cited as Irish Standard/EN ISO/IEC 10536-1:1995 or as I.S./EN ISO/IEC 10536-1:1995.
