SPRING-TYPE STRAIGHT PINS - COILED, LIGHT DUTY (ISO 8751 : 1997)

NSAI in exercise of the power conferred by section 16 (5) of the National Standards Authority of Ireland Act, 1996 (No. 28 of 1996) and with the consent of the Minister for Enterprise, Trade and Employment, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Spring-type straight pins - Coiled, light duty (ISO 8751 : 1997)) Declaration, 1998.
2. (1) The Specification set forth in the Schedule to this declaration is hereby declared to be the standard specification for Spring-type straight pins - Coiled, light duty (ISO 8751 : 1997). Schedule comprises the text of EN ISO 8751:1997.

(2) The said standard specification may be cited as Irish Standard EN ISO 8751 :1998 or as I.S. EN ISO 8751:1998.
3. (1) The Standard Specification (Spring-Type Straight Pins – Coiled, Standard Duty (ISO 8751:1987)) Declaration, 1993 is hereby revoked.

(2) Reference in any other standard specification to the Instrument hereby revoked and to Irish Standard/EN 28751:1993 thereby prescribed, shall be construed, respectively, as references to this Instrument and to Irish Standard/EN ISO 8751:1998.
