1 Scope

This part of EN 50363 specifies the requirements for the physical properties of the cross-linked elastomeric sheathing compounds given in Table 1. The relevant test methods are given in EN 60811 series and EN 50396.

NOTE This part of EN 50363 is to be read in conjunction with EN 50363-0.

Table 1 - Types of cross-linked elastomeric sheathing compound

| EM 4 | 110 | Ordinary duty – EVA or equivalent synthetic elastomer |
| EM 6 | 90 | Ordinary duty and including use down to -40 °C – EPR or equivalent synthetic elastomer; for cables insulated with EI 6 |
| EM 7 | 90 | Ordinary duty CSP or equivalent synthetic elastomer; for cables insulated with EI 7 |
| EM 9 | 180 | Ordinary duty Silicone rubber |

3 Definitions

For the purposes of this part of EN 50363, the definitions given in EN 50363-0, Clause 3, apply.

4 Properties

Each compound shall meet the particular requirements listed in Table 2, when using the test methods referenced in columns 4 and 5.

NOTE For cross-references to the latest editions of the test method standards see Table 2 of EN 50363-0.
