**AMENDMENT**  
OF  
**STANDARD SPECIFICATION (FLAMMABILITY OF CHILDREN'S  
NIGHTDRESSES) DECLARATION, 1966**

---

The Institute for Industrial Research and Standards in exercise of the power conferred by section 20(3) of the Industrial Research and Standards Act, 1961 (No. 20 of 1961), and with the consent of the Minister for Industry and Commerce, hereby declares as follows:

1. This instrument may be cited as the Standard Specification (Flammability of Children's Nightdresses) Declaration, 1966, (Amendment) 1969.
2. Irish Standard 148 : 1966 set out in the Schedule to the Standard Specification (Flammability of Children's Nightdresses) Declaration, 1966, is hereby amended as indicated in the Schedule hereto.

**SCHEDULE**

**Clause 3:** *Delete the text and substitute the following:*

3. (i) Subject to Sub-Clause (ii) of this Clause, children's nightdresses shall not be made of, or trimmed below the waist or elbow with, any fabric of a kind not capable of satisfying the flame-resistance rating and durability requirements of Irish Standard 128: 1964.
- (ii) The requirements set out under the heading "Test Specimens (c) Preparation of specimens for test" in Appendix A of the said Irish Standard 128: 1964 shall, in the case of children's nightdresses, be modified in such a way that, where it is not possible to cut from such a nightdress six specimens of the type described under the said heading, the maximum possible number of such specimens shall be cut, and the other provisions of the said Irish Standard 128: 1964 shall be construed accordingly.
- (iii) Where fabric with which a children's nightdress is made or trimmed contains fibres made of a synthetic substance which will melt with the application of heat—  
any fabric stitched or otherwise attached to the fabric of the nightdress below the waist or elbow of the nightdress shall be of the same kind or of a kind consisting wholly of fibres which will melt with the application of heat; and  
any thread with which the fabric of the nightdress is stitched shall be of a kind which will melt with the application of heat.
- (iv) The above requirements do not prohibit the use of elastic or elastic thread for shirring.
