- d) hexagon bolts with flange (ISO 4162, ISO 15071 and ISO 15072);
- e) hexagon nuts with flange (ISO 4161, ISO 7043, ISO 7044, ISO 10663, ISO 12125, ISO 12126 and ISO 21670).
