- d) hexagon bolts with flange (ISO 4162, ISO 15071 and ISO 15072);
- e) hexagon nuts with flange (ISO 4161, ISO 7043, ISO 7044, ISO 10663, ISO 12125, ISO 12126 and ISO 21670).



# Hexagon regular nuts (style 1) — Product grade C

## 1 Scope

This International Standard specifies the characteristics of hexagon regular nuts (style 1) with threads from M5 up to and including M64 and product grade C.

If, in special cases, specifications other than those listed in this International Standard are required, they can be selected from existing International Standards, for example ISO 724, ISO 898-2, ISO 965-1 and ISO 4759-1.
