Introduction

Replace the addition of CENELEC common modifications by the following:

The principle objectives of Low Voltage Directive, 2006/95/EC, are covered in this standard. The essential safety requirements of the Machinery Directive 2006/42/EC have also been taken into account for appliances covered by this part.

1 Scope

Replace the second and third paragraph of EN 60335-2-65 with the following:

This European Standard deals with the safety of electric **air-cleaning appliances**, their maximum **rated voltages** being not more than 250 V for single phase and 480 V for others.

Appliances and machines intended to be used in household, commercial applications, in shops, in light industry and on farms, are within the scope of this standard.

Additional requirements for appliances and machines intended for commercial use are given in Annex ZE.

NOTE Z1 Examples of appliance for household environment are appliances for typical housekeeping functions used in the household environment and appliances for typical housekeeping functions used by non expert users:

- in shops, offices and other similar working environments;
- in farm houses;
- by clients in hotels, motels and other residential type environments;
- in bed and breakfast type environments.

NOTE Z2 Household environment includes the dwelling and its associated buildings, the garden, etc.

NOTE Z3 Appliances built into building ventilation system are also within the scope of this standard.

Specific additional requirements for appliances and machines intended for commercial use

The following modifications to this standard are applicable for appliances and machines intended for commercial use.

Introduction

Replacement:

For the verification of compliance of appliances or machines intended for commercial use with the Essential Health and Safety Requirements (EHSR) of the Directive 2006/42/EC, the requirements in this Annex ZE shall apply.

1 Scope

This annex deals with additional requirements concerning appliances and machines intended to be used by expert or trained users in shops, in light industry and on farms, and appliances and machines which are declared to be for commercial use by lay persons.

NOTE The statement from the manufacturer in the product information concerning the specific product is the criterion that has to be considered to determine the intended use of the appliance. Evidently this must accurately reflect the reasonably foreseeable use of the product.

Products covered by these standards do not create a noise hazard, therefore no specific provisions concerning noise are given.

3 Definitions

This clause of Annex ZE of Part 1 is applicable.

4 General requirement

This clause of Annex ZE of Part 1 is applicable.

7 Marking and instructions

This clause of Annex ZE of Part 1 is applicable except as follows:

7.12 *Addition:*

The instructions shall indicate the substance of the following:

“This appliance is designed to be used in commercial areas”.

7.12.Z1 *To replace the sixth dashed item by the following:*

- that the A-weighted emission sound pressure level is below 70 dB(A).

p Add:

An investigation by CENELEC TC 61 has shown that all risks from products within the scope of this standard are fully covered by the Low Voltage Directive, 73/23/EEC. For products having mechanical moving parts, a risk assessment in accordance with the Machinery Directive, 98/37/EC, has shown that the risks are mainly of electrical origin and consequently this directive is not applicable. However, the relevant essential safety requirements of the Machinery Directive are covered by this standard together with the principal objectives of the Low Voltage Directive.

This part 2 is to be used in conjunction with the latest edition of IEC 60335-1 and its amendments. It was established on the basis of the fourth edition (2001) of that standard.

NOTE 1 When "Part 1" is mentioned in this standard, it refers to IEC 60335-1.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert that publication into the IEC standard: Safety requirements for electric air-cleaning appliances.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- unless notes are in a new subclause or involve notes in Part 1, they are numbered starting from 101, including those in a replaced clause or subclause;
- additional annexes are lettered AA, BB, etc.

NOTE 3 The following print types are used:

- requirements: in roman type;
- *test specifications: in italic type;*
- notes: in small roman type.

Words in **bold** in the text are defined in Clause 3. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

The following differences exist in the countries indicated below.

- 8.1.4: The measurement method and maximum energy discharge are different (USA).
- 16.101: The test is different (USA).
- 22.101: This test is not carried out (USA).
- 24.101: The contact separation need not be in accordance with IEC 61058-1 (USA).
- Clause 32: This test is only applicable for portable appliances (USA).

The committee has decided that the contents of the base publication and its amendments will remain unchanged until the maintenance result date indicated on the IEC web site under "<http://webstore.iec.ch>" in the data related to the specific publication. At this date, the publication will be

- reconfirmed,
- withdrawn,
- replaced by a revised edition, or
- amended.

NOTE 4 The attention of National Committees is drawn to the fact that equipment manufacturers and testing organizations may need a transitional period following publication of a new, amended or revised IEC publication in which to make products in accordance with the new requirements and to equip themselves for conducting new or revised tests.

It is the recommendation of the committee that the content of the amendment 1 be adopted for implementation nationally not earlier than 12 months or later than 36 months from the date of publication.

INTRODUCTION

It has been assumed in the drafting of this International Standard that the execution of its provisions is entrusted to appropriately qualified and experienced persons.

This standard recognizes the internationally accepted level of protection against hazards such as electrical, mechanical, thermal, fire and radiation of appliances when operated as in normal use taking into account the manufacturer's instructions. It also covers abnormal situations that can be expected in practice and takes into account the way in which electromagnetic phenomena can affect the safe operation of appliances.

This standard takes into account the requirements of IEC 60364 as far as possible so that there is compatibility with the wiring rules when the appliance is connected to the supply mains. However, national wiring rules may differ.

If an appliance within the scope of this standard also incorporates functions that are covered by another part 2 of IEC 60335, the relevant part 2 is applied to each function separately, as far as is reasonable. If applicable, the influence of one function on the other is taken into account.

When a part 2 standard does not include additional requirements to cover hazards dealt with in Part 1, Part 1 applies.

NOTE 1 This means that the technical committees responsible for the part 2 standards have determined that it is not necessary to specify particular requirements for the appliance in question over and above the general requirements.

This standard is a product family standard dealing with the safety of appliances and takes precedence over horizontal and generic standards covering the same subject.

NOTE 2 Horizontal and generic standards covering a hazard are not applicable since they have been taken into consideration when developing the general and particular requirements for the IEC 60335 series of standards. For example, in the case of temperature requirements for surfaces on many appliances, generic standards, such as ISO 13732-1 for hot surfaces, are not applicable in addition to Part 1 or part 2 standards.

An appliance that complies with the text of this standard will not necessarily be considered to comply with the safety principles of the standard if, when examined and tested, it is found to have other features that impair the level of safety covered by these requirements.

An appliance employing materials or having forms of construction differing from those detailed in the requirements of this standard may be examined and tested according to the intent of the requirements and, if found to be substantially equivalent, may be considered to comply with the standard.

HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES – SAFETY –

Part 2-65: Particular requirements for air-cleaning appliances

1 Scope

This clause of Part 1 is replaced by the following.

This International Standard deals with the safety of electric **air-cleaning appliances** for household and similar purposes, their **rated voltage** being not more than 250 V for single-phase appliances and 480 V for other appliances.

Appliances not intended for normal household use but that nevertheless may be a source of danger to the public, such as appliances intended to be used by laymen in shops, in light industry and on farms, are within the scope of this standard.

As far as is practicable, this standard deals with the common hazards presented by appliances that are encountered by all persons in and around the home. However, in general, it does not take into account

- persons (including children) whose
 - physical, sensory or mental capabilities; or
 - lack of experience and knowledgeprevents them from using the appliance safely without supervision or instruction;
- children playing with the appliance.

NOTE 101 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on board ships or aircraft, additional requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible for the protection of labour and similar authorities.

NOTE 102 This standard does not apply to

- appliances intended exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- air-cleaning systems incorporated in the building structure.
