STANDARD SPECIFICATION (MATTRESS TICKING), 1958.

The Institute for Industrial Research and Standards in exercise of the power conferred by section 2 of the Industrial Research and Standards (Amendment) Act, 1954 (No. 11 of 1954), and with the consent of the Minister for Industry and Commerce (signified by his Official Seal affixed hereto), hereby declares as follows:

- 1. This instrument may be cited as the Standard Specification (Mattress Ticking), 1958.
- 2. (1) The specification set forth in the Schedule shall be the standard specification for Mattress Ticking.
- (2) The said standard specification may be cited as Irish Standard 90:1958 or I.S. 90:1958.

SCOPE

1. This specification relates to ticking for mattresses containing fibre, hair, and interior spring units.

Types

2. The types of mattress ticking covered by this specification are set out in Table 1.

Type 2	Striped Ticking for Hair Mattresses	Cotton.
Type 3	Damask Ticking for Fibre Mattresses	Synthetic Fibre.
Type 4	Damask Ticking for 3rd Quality Spring Interior Mattresses	Cotton.
Type 5	Damask Ticking for 3rd Quality Spring Interior Mattresses.	Synthetic Fibre.
Туре 6	Damask Ticking for 3rd Quality Spring Interior Mattresses.	Continuous Filament Rayon.
Type 7	Damask Ticking for 2nd Quality Spring Interior Mattresses	Synthetic Fibre.

Composition

3. The yarn in the warp shall be spun entirely from thoroughly cleansed cotton free from waste. The yarn in the weft shall be either composed of continuous filament rayon or spun from synthetic fibre or from thoroughly cleansed cotton free from waste, as set out for each type in Table 1.
