1 Modification to the European Foreword

Add as 5th paragraph the following:

"For the purposes of global relevance, the requirements of all clauses referring to ISO/TS 3691-7 have been transferred and published as European Standard EN 16307-5, *Industrial trucks — Safety requirements and verification — Part 5: Supplementary requirements for pedestrian-propelled trucks.*"

2 Modification to Annex ZA

In Annex ZA, 2nd paragraph, add after "clause 6.2.7" the following: "and with the exclusion of all references to ISO/TS 3691-8"

to read:

"Once this standard is cited in the Official Journal of the European Union under that Directive and has been implemented as a national standard in at least one Member State, compliance with the normative clauses of this standard, except clause 6.2.7 and with the exclusion of all references to ISO/TS 3691-8 confers, within the limits of the scope of this standard, a presumption of conformity with the corresponding Essential Requirements of that Directive and associated EFTA regulations.".
